

State Labor Poster and Notice Requirements

This document provides direct links to the workplace posters employers are required to display under federal law. These posters, including official translated versions, are created and updated by government agencies. Employers must also comply with all applicable state posting requirements.

Employers must display required posters in a public place where employees can easily access them. While most posters apply to all employers, some may apply to specific industries or employers of a certain size. Employers can review each poster description to determine whether they are required to display that particular poster.

POSTERS REQUIRED FOR CERTAIN EMPLOYERS

Antidiscrimination poster

Required for any Nevada employer receiving financial assistance under Title I of the Workforce Investment Act.

Paid Leave poster

Required for private employers with 50 or more employees. This is paid leave that can be taken for any reason, not just for sickness.

No smoking signs

Any Nevada place of employment where smoking is prohibited shall post, at every entrance, a conspicuous sign clearly stating that smoking is prohibited. Employers must clearly and conspicuously post “no-smoking” signs at building entrances and in areas where smoking is not allowed.
