State Labor Poster and Notice Requirements

This document provides direct links to the workplace posters employers are required to display under federal law. These posters, including official translated versions, are created and updated by government agencies. Employers must also comply with all applicable state posting requirements. Employers must display required posters in a public place where employees can easily access them. While most posters apply to all employers, some may apply to specific industries or employers of a certain size. Employers can review each poster description to determine whether they are required to display that particular poster.

Required for personal service establishments, drinking establishments (that have been found to be a nuisance), adult entertainment enterprises, hotels or motels found to be a nuisance, airports, trains, bus stations, welcome centers and rest areas, and full-service truck stops.

No smoking signs

Required for employers subject to the Pennsylvania Clean Indoor Air Act. Businesses where smoking is prohibited under this act are required to post "No Smoking" signs prominently at entrances and inside the building. Businesses that are not covered by this act must post "Smoking Permitted" signs at their entrance.
