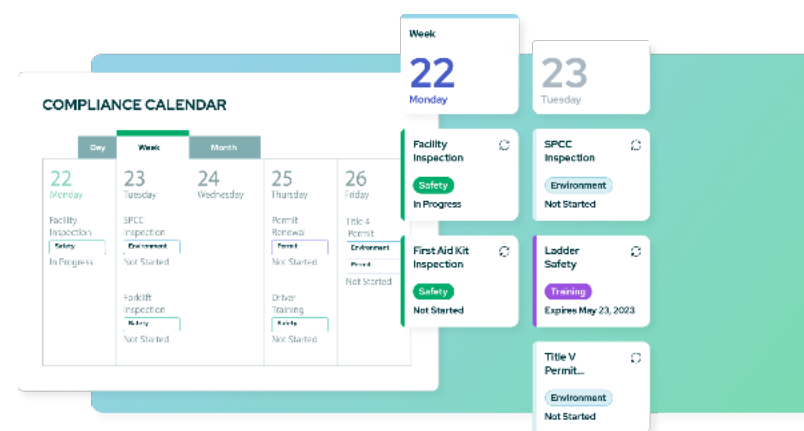
Schedule Inspections	Create an “equipment type” including what inspections need to be completed and how often.
Assign Inspections	Assign an equipment inspection to any employee. When the inspection status expires, the assignees will receive a task in their open-task list.
Inspection Status Reports	Run inspection status reports any time to see which assets have up-to-date, expiring, or expired inspections.
QR Codes	Each asset is assigned a QR code. Team members can simply scan a QR code and perform an inspection in seconds.



Compliance Calendar

Gaining visibility into all the activities and tasks within an EHS Program is critical to its success. With KPA Flex’s Compliance Calendar, you can access and organize all your compliance and training tasks—completed and pending—and take critical actions from within the calendar view.

- ◆ Rely on calendar for environmental permit tracking and audits.

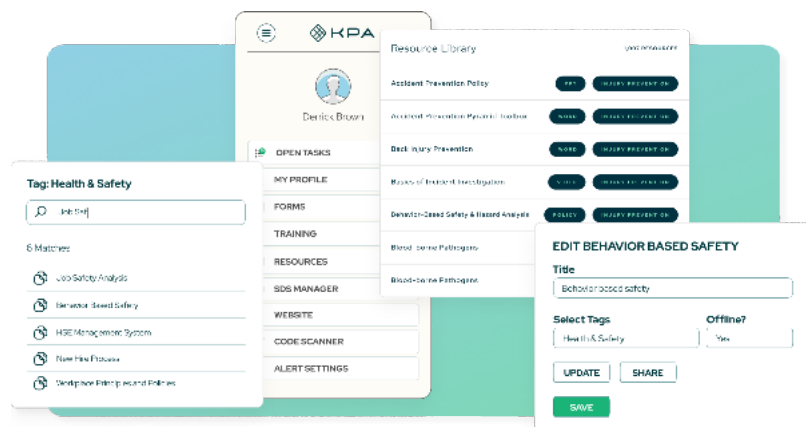


Resource Library

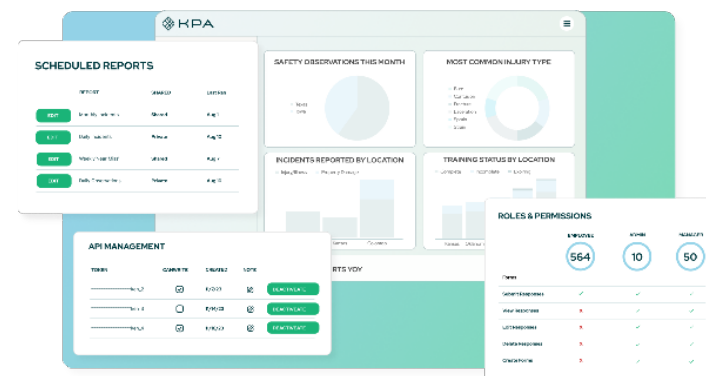
